

ORDINANCE NO. 1994(6)

AN ORDINANCE AMENDING THE HOPKINS COUNTY SOLID WASTE MANAGEMENT PLAN, OCTOBER, 1992.

WHEREAS, the governing body of Hopkins County, the Hopkins County Fiscal Court has proposed to amend the Hopkins County Solid Waste Management Plan by changing Chapter 1, Section 2, beginning on page 2 and continuing on page 3 of the Solid Waste Management Plan for Hopkins County, Kentucky. And

WHEREAS, the Fiscal Court has determined that Section 2 of the plan shall be amended by changing the governing body for the Solid Waste Management Area from the Hopkins County Solid Waste 109 Board to the Hopkins County Fiscal Court. And

WHEREAS, the Hopkins County Solid Waste District shall be managed by and operated by the Fiscal Court rather than a Board of Directors appointed by the Hopkins County Judge/Executive and confirmed by the Hopkins County Fiscal Court. And

WHEREAS, the Fiscal Court has determined that the authority granted to the Hopkins County Solid Waste 109 Board should be withdrawn and the Board abolished, and that the Fiscal Court should assume all responsibilities and authorities of the 109 Board.

NOW THEREFORE, BE IT ORDAINED by the Fiscal Court of Hopkins County that the Hopkins County Solid Waste Management Plan shall be amended by changing Chapter 1, enumerated Section 2, beginning on page 2 and continued on page 3 of said plan as follows:

2. Designation of Governing Body -


The governing body for the County's Solid Waste Management Area shall be the Fiscal

Court of Hopkins County. The Fiscal Court shall be responsible for the implementation of the Solid Waste Management Plan and it shall have the power to plan, initiate, acquire, construct and maintain solid waste facilities, and promulgate regulations with respect thereto in accordance with applicable laws.

The Hopkins County Solid Waste District shall be managed by and operated by the Hopkins County Fiscal Court.

The Solid Waste Management Plan for Hopkins County, Kentucky, is amended or altered in no other respect.




