ORDINANCE NO. 1995(14) 1996 (1)

AN ORDINANCE OF HOPKINS COUNTY, KENTUCKY, RELATING TO AN INTERLOCAL AGREEMENT BETWEEN THE CITY OF ST. CHARLES AND HOPKINS COUNTY, PROVIDING FOR THE PLACEMENT OF A DRAINAGE STRUCTURE ON PRINCETON STREET

WHEREAS, the Department of Rural and Municipal Aid has agreed to provide the City of St. Charles with sufficient funds, specifically Thirty Eight Thousand Three Hundred Sixty Seven Dollars (\$38,367) for a project for the construction of a drainage structure on Princeton Street, located over a stream 100 feet west of Kentucky 454 in St. Charles; and

WHEREAS, the City of St. Charles does not have sufficient employees and equipment to construct this drainage facility in accordance with the specifications of the Commonwealth of Kentucky. And

WHEREAS, it would be in the best interest of the traveling public to replace this drainage structure.

NOW THEREFORE, BE IT ORDAINED by the Fiscal Court of Hopkins County that pursuant to KRS Chapter 65, the Fiscal Court agrees to enter into an Interlocal Agreement with the City of St. Charles, provided the City of St. Charles passes the appropriate Ordinances, providing for the construction of a drainage structure on Princeton Street located in St. Charles, Kentucky.

BE IT FURTHER PROVIDED that said agreement shall include a provision that the County shall cause the project to be constructed to a level meeting applicable state road and bridge standards as required by the Transportation Cabinet, Department

of Rural and Municipal Aid.

BE IT FURTHER ORDAINED that the costs of the construction of said structure shall not exceed an amount of Thirty Eight Thousand Three Hundred Sixty Seven Dollars (\$38,367) and the City of St. Charles shall agree to reimburse or pay that amount to Hopkins County for the construction of said drainage structure.

BE IT FURTHER ORDAINED that prior to the construction of said drainage structure, the County shall verify and confirm that the city of St. Charles has sufficient funds to pay for the construction of this project.

UPON MOTION by Magistrate Welch, seconded by Magistrate Stanley, first reading was held on the 20th day of June, 1996.
